These agencies will be granted certificate of provisional recognition for a period of 6 months from the date of provisional recognition or till they are recognized under the final Food Safety and Standards (Food Safety Auditing), 2017 whichever is earlier. As intimated earlier in the EOI, the fee for grant of recognition/ renewal is Rs. 30,000/-. The fee is non-refundable and has to be paid in the form of DD in favour of Senior Accounts Officer, FSSAI payable at Delhi. The certificate of provisional recognition shall be mailed to the agency after receipt of recognition fee.
