1. The highest offer of the vehicle will be treated as successful bidder provided the same is accepted by the Competent Authority.
2. The successful bidder will be required to deposit total amount by way of Demand Draft/Pay Order / Banker's cheque in favour of "Sr Pay Accounts Officer, FSSAI", New Delhi.
3. If the successful bidder accepted by the Competent Authority in FSSAI fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited.
4. In case the offer is withdrawn by any bidder, the earnest money deposited by him shall be forfeited. EMD of the successful bidder(s) will be released only after realization of Sale proceeds amount. EMD of the bidders who fail to honor the bid in prescribed time limit shall stand forfeited.
